### UNAUDITED RESULTS FOR THE SECOND QUARTER AND THE FIRST HALF OF 2018 OF CHINA BIOLOGIC PRODUCTS HOLDINGS, INC.

This announcement is made by PW Medtech Group Limited (the “**Company**”) pursuant to the requirements of Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

China Biologic Products Holdings, Inc. (“**CBPO**”), a major operating associate of the Company, is a company listed on The NASDAQ Stock Market LLC. As of the date of this announcement, the Company owns approximately 16.51% of the outstanding share capital of CBPO as the single largest shareholder. On August 3, 2018, the board of directors of CBPO approved the release of its unaudited financial results for the second quarter of 2018. A press release announcing its unaudited financial results for the second quarter and the first half of 2018 (the “**Press Release**”) was filed with the United States Securities and Exchange Commission.
